#### **Commissioner Dash:**

- Attended the Sadbhavna Samaroh (Goodwill Gathering) on January 10, 2015 at the North Bellevue Community Center organized by WASITRAC with the support from Asian Counseling & Referral Services (ACRS), Nepal Seattle Society, Tasveer and the India Association of Western Washington. The well-know Singer from India, Karma Sherpa performed at the show singing some Nepali and Hindi songs.
- The celebration of 66th Republic Day of India was celebrated at held at the Bellevue High School on January 25, 2015. Attended the event along with Congressman Adam Smith and State Rep. Pramila Jayapal who were the invited speakers. Nearly 500 members of the East Indian Community attended this event amidst colorful cultural programs and exhibits.
- On January 26th State Rep. Pramila Jayapal brought a Senate Resolution to honor the numerous contributions that Indian-Americans have made to the State of Washington and a formal recognition of the 66th year anniversary of India's Republic Day. It was the day of January 26, 1950 when the constitution of independent India was adopted defining India as a secular, socialist, democratic, and republic nation. Many prominent community members from the East Indian community attended and watched from the senate gallery as the resolution was formally adopted by the Senate.

Since 2003, StoryCorps has collected and archived more than 50,000 interviews from more than 80,000 participants. Millions listen to StoryCorps' weekly broadcasts on National Public Radio (NPR's) Morning Edition and on StoryCorps' Listen Page. StoryCorps' mission is to provide people of all backgrounds and beliefs with the opportunity to record, share and preserve the stories of our lives. They do this to remind one another of our shared humanity, to strengthen and build the connections between people, to teach the value of listening, and to weave into the fabric of our culture the understanding that everyone's story matters. At the same time, they are creating an invaluable archive for future generations. StoryCorps core principle is built on an uncompromising commitment to excellence throughout the organization that includes an intense focus on the collecting, sharing, and preserving of people's stories; high-quality organizational management; and the care and support of an extraordinary work environment where respect and dignity are paramount.
- TBIP Transitional Bilingual Instructional Program Task Force Committee February & March: Unlocking the research on English Language Learners. Quality instructional practices are good for everybody, including English Language Learners. There is an emphasis on recognizing the value of home language. For educators and parents, that is a huge statement. Bilingual education tends to produce the same if not better experiences that non-bilingual. At the state level, are we able to think about conducting research about programs? Revising State Achievement Index. Reviewing current, former and ever ELLs, English Language Acquisition Award, recognizing high performance schools in the areas of English Language Acquisition. Update on OSPI Guidance on Program Models: Content Based and Sheltered Instruction Models.

Following the model of urban teacher residency programs in cities such as Boston, Chicago, and Denver. This particular residency program successfully apply the medical residency model to teacher preparation. By blending classroom apprenticeship with aligned graduate-level course work and an intensive resident/mentor partnership, residencies aim to accelerate student achievement through the training, support and retention of excellent teachers. The Seattle Teacher Residency deepens this commitment by recruiting, preparing, and supporting teachers equipped to make sure that each student excels and feels connected to the school community, regardless of circumstance. Seattle Teacher Residency's mission is to accelerate student achievement through the preparation, support, and retention of a group of exceptional teachers in Seattle Public Schools whose diversity reflects the demographics of their students.
- Foster High School Centennial Celebration March 21, 2015. Attend Foster High School's one hundred years in the making on March 21<sup>st</sup>. Over the past century, Foster has transitioned from a simple building in a Northwest settlement area to the sole high school in the nation's most diverse school district. Throughout the significant changes, the most important character of Foster is that the school remains the heart of the Tukwila community. Asian and Pacific Islander students took stage for vibrant cultural performances.
- Community Forum: Closing the Education Opportunity Gap March 14, 2015: Master of Ceremonies/facilitating for Closing the Education Opportunity Gap Forum. Three goals accomplished at forum: Raise awareness about how data informs and impacts the AAPI opportunity gaps. Learn about ways community members and leaders can provide feedback or participate in efforts to close the opportunity gaps. Gain an understanding about how policy makers are working towards closing the opportunity gaps. Education opportunity gaps result when students, families, communities do not have equitable access to quality education, services and resources they need to succeed in the education system. Research teams; Dolly Nguyen and Robert Teranishi from UCLA presented updated data on API's. Sili Savusa and Freda Takamura from EOG, Rep. Sharon Tomiko Santos as guest speaker.

o If you have personal items of value, leave them at home.

- o If you have to bring personal items, get a fanny pack and keep them on you at all time. Do not leave your keys unattended anywhere.
- o Use a lock on your gym locker.
- o Be aware of your surroundings when you get to the parking lot and report any suspicious activity.
- o Keep a written record of values, including description and serial numbers. These are proof that property is yours and will aid in the reporting process and recovery.
- o Report missing or stolen property immediately.
